Background

Aspire Health Partners was founded in 2014 through the merger of three of Centra Florida's largest behavioral healthcare providers: Lakeside Behavioral Healthcare, Inc; Seminole Behavioral Healthcare, Inc; and The Center for Drug-Free Living, Inc. All three agencies were established between 1969-1971, giving Aspire Health Partners over 50 years of operating presence in the communities it serves. All three companies had a rich history of providing behavioral health services in the Central Florida community, including serving low-income individuals who would otherwise be unable to afford services. Aspire's continuum of care is expansive, with a variety of inpatient, outpatient, residential, and community-based prevention services. Aspire's staff of over 1,100 professionals and over 50 programs at over 20 program sites continue to successfully serve the Central Florida community in beyond. In recent years, Aspire has been a champion of the CCBHC model in the State of Florida, working with federal, state, and local government partners to upgrade and enhance the services available at the agency. Aspire also has expended services through its partnership with the Steven A. Cohen foundation, with the operation of two Military Family Clinics. Aspire's clinic in Tampa offers telehealth services to the Central Florida and South Florida regions, while the clinic in Hinesville, Georgia offers services throughout the state. In addition to this geographic expansion, Aspire has piloted many new services and treatment modalities, participated

in research studies, and increased services to groups with specialized needs such as Veterans and victims of human trafficking. Aspire continues to serve over 42,000 clients per year across its continuum. Services continue to be provided regardless of age, sex, creed, race, sexual orientation, marital status, or ability to pay, and Aspire continually works to remain on the cutting edge of behavioral healthcare and to maintain its high standing with all accreditation and oversight organizations who provide funding. As Aspire continues to move forwards, the organization is committed to furthering its mission and accomplishing its vision of saving lives, transforming communities, and changing the world.

Impact

Aspire has continued to see success in delivering high-guality, affordable, and comprehensive behavioral health care to the people of Central Florida. Over the course of the past year and fiscal year, Aspire has: • Provided over 43,000 clients with over 750,000 individual services, including 57,000 inpatient bed days, 118,000 residential bed days, and 90,000 prescriptions filled through the pharmacy. • Enhanced and expanded Primary Care services through the Certified Community Behavioral Health Clinic Program and Aspire's Centers of Excellence • Began the steps of developing a Central Receiving System in Seminole County following the model Aspire currently implements in Orange County, as well as opening the Seminole County/Fernwood Center of Excellence at this location with the provision of Medication Assisted Treatment and Primary Care. • Continued to operate and expand the new Mobile Response Team in both Orange and Seminole County, as well as the City of Orlando Community Response Team. Continued operations of several Service Centers of Excellence which will focus on Whole Person Integrated Healthcare and implemented new organizational structures to foster the integrated care model. • Beaun providing medical services at Orange County Corrections including Medication Assisted Treatment for Substance Use and Long-Acting Injectables for psychiatric illnesses. • Opened a new 23-Successfully upgraded all HR and Electronic Health Record hour Intensive Inpatient Unit. software to a new comprehensive system. Aspire's Call Center successfully fielded nearly 40,000 calls in the first six months of 2023. Celebrated the 20th anniversary of the Belvin Perry Jr. Central Receiving Center (CRC) in Orange County. Additionally, the CRC served over 2,300 admissions in the first six months of 2023. Continued to perform positively in fiscal management as reflected by the company's annual audit with no negative findings. • Was recognized as one of 100 Top Women Lead Businesses. • Secured a \$2.5 million grant from Orange County for the expansion of Medication Assisted Treatment, Assisted Outpatient Treatment, and Psychosocial Rehabilitation in the region • Begun providing services on a new SAMHSA "TREE" grant serving adolescents, transition-age youth, and their families. • Began provided expanded CIT trainings to local law enforcement and first responders through a Mental Health Awareness Training grant from SAMHSA • Replaced and upgraded the roof at the Fernwood Campus after damages from Hurricane Ian • Reviewed and optimized Transportation Department fleet and expenses to provide more transports at lower costs while still providing over 10,000 client trips yearly • Continued Clinical-Academic Research Partnerships with UCF, NOVA University, and the University of Washington • Continued to build new housing for homeless Veterans in partnership with Aspire's VA GPD program for homeless Veterans. Continued operations of the new Steven A. Cohen Military Family Clinic in Hinesville, GA • Participated in and conducted outreach at over 24 different community events.

Needs

Aspire's financial needs vary from program to program, due to the organization's diverse profile of services throughout the Central Florida area. Funds are often needed for capital improvements to facilities, improvement and enhancement at individual programs, and general operating funding that can be used to replace public funding that may have limited availability. Aspire also often frequently operates short-term pilot programs funded by outside agencies. Once this funding has been completed, third-party funding and assistance is needed to continue these programs. Because Aspire primarily operates utilizing specific and restricted funding sources, unrestricted operating funds are very useful due to the organization's ability to flexibly assign them to areas of the most need that may be experiencing shortfalls. Aspire's current goals include expanding Service Centers of Excellence which will provide single-location comprehensive services including counseling, psychiatric care, medication-assisted treatment, primary care, and supportive services such as case

management at a variety of Aspire's locations across its continuum. Funding to support this initiative would be helpful. Additionally, many clients struggle with access to housing and basic needs, especially those in case management, psychosocial rehabilitation, and other outpatient services, or those exiting residential programs. Incidental funding to assist with short-term housing or other basic needs for these programs, especially those that serve homeless adults, are always needed. Aspire seeks to offer supportive services and experiential therapy at its residential programs. Funding for exercise equipment and classes, art and music therapy, and outings for youth programs are sought in order to enhance treatment. Additionally, many outpatient programs for youth or young adults need additional funding to encourage engagement in peer support groups including trips and outings.

The reality for most people with mental illness is that they have a constant sense of not fitting in, of isolation, and rejection. Mental illness has the devastating effect of separating people from others in society. A Clubhouse is a community intentionally organized to support individuals living with the effects of mental illness. Through participation in a clubhouse, people are given the opportunity to rejoin the world of friendships, family, important work, employment, education and to access the services and support they may individually need. A clubhouse is a restorative environment for people who have had their lives drastically disrupted and need the support of others who believe that recovery from mental illness is possible for all. The clubhouse offers individuals supported employment, supported housing, reach out (a phone call to check on members) and community support. **Budget** \$353,320

The majority of Americans worry more about home decorating and lawns than having a safe and warm (or cool) place to sleep. Mental Health Services

Description

After an initial crisis many individuals require aftercare in the form of continued mental health services to maintain their recovery. Aftercare services can offer support, education and stabilization. Aspire offers many services to assist individuals with recovery such as Case Management Services, Medication Management, Outpatient Therapy and Residential Services. These services focus on holistic recovery and work hand and hand with supporting individuals on the journey of recovery. Often times individuals who are seeking treatment come to us without the ability to pay for services because they are considered indigent or meet the federal definition of poverty. The average cost of a month's supply of one medication is \$125.00. Someone who is living in recovery can take several medications a day to remain stable on in the community. Many times individuals and families have to make tough decisions regarding choosing between medications or household bills. These decisions can have very drastic affects on the individual and family. Even when choices are made to pay for medications there is not money left for support services such as individual or group therapy. Individual and Corporate donations can allow us to take these choices away and offer all services needed for recovery. Budget \$560,000

CENTAUR-HIV/AIDS & Hepatitis Services

Description

The mission of CENTAUR is to reduce the incidence of HIV and Hepatitis infection in our community and to improve the quality of life for persons who are infected or affected by HIV/AIDS and/or Hepatitis. Services are designed to address the factors associated with the risk or progression of infection. CENTAUR provides confidential testing; mental health counseling; community referrals; comprehensive education sessions; and substance abuse assessment & counseling. In addition, CENTAUR also provides HOPWA (Housing Opportunities for Persons with HIV/AIDS) services for those individuals infected with HIV/AIDS and are experiencing a threat of homelessness or are already homeless. Program services include short-term rental, mortgage, and/or utility assistance for people living with HIV/AIDS and their families. In addition, facility-based housing is available, based on eligibility, for those people living with HIV/AIDS in need of substance abuse and/or mental health treatment services. In addition to being a HOPWA provider, CENTAUR is also a Ryan White provider Budget

Inpatient Psychiatric Care (CSU's and Hospital Units)

Description

Crisis Stabilization Unit (CSU) provides secure, short-term, in-patient psychiatric care for individuals needing emergency, mental health treatment. Aspire's CSUs are Baker Act Receiving Facilities and accept both voluntary and involuntary admissions from law enforcement, hospital emergency departments, medical and behavioral health professionals, as well as voluntary self-referrals. Aspire operates two individual CSUs including: one in Orange County and one in Seminole County. Aspire also operates a Behavioral Health Hospital in Orange County providing shortterm, inpatient psychiatric treatment for adults and a Short-Term Residential unit in Orange County for individuals who need a longer than usual amount of time to stabilize. Aspire also operates a 23 Hour Extended Observation Unit which provides support and assistance for individuals who need inpatient stabilization but whose needs can be resolved in less than 24 hours.

Short-Term Mental Health Residential

Description

Aspire operates two short-term mental health residential treatment programs for individuals who need additional stabilization and support before returning to independent living. In Seminole County, Bay House is a 12 bed short-term facility that assists individuals with serious and persistent mental health issues in learning to live more independently in the community. The program is staffed 24 hours a day, and most residents stay for approximately three months. In Orange County, College Place apartments has multiple programs that provides supervised transitional housing to individuals with mental illness. The program is a point of entry for adults, including the homeless, with severe and persistent mental illnesses who need additional support until they have regained the skills necessary for more independent living.

Psychosocial Rehabilitation

Description

Aspire's Turning Point in Seminole County is a Psychosocial Rehabilitation program that is active, goal oriented and time limited. The primary focus of the program is to assist participants in learning and developing the necessary social and behavioral skills they need to successfully live in the community as independently as possible. Each client works with an assigned Primary Counselor in a collaborative relationship to establish their personal goals for treatment and to select group courses to assist them in working toward these goals. Group activities focusing on skill development - both cognitive and behavioral - are used to achieve increased interpersonal skill development, socialization and independence for clients. Individual meetings with the Primary Counselor and optional workshops are also provided during program hours to assist those looking to enhance their treatment with the Turning Point Program. Clients are strongly encouraged to take ownership and responsibility for treatment and recovery. Transportation services are available for Seminole County residents.

Aspire recently expanded our Psychosocial Rehabilitation program into Orange County with I-PSR, a three year pilot program in partnership with AdventHealth. I-PSR follows the same treatment model as Turning Point, and accepts referrals from individuals in need of follow up care after being psychiatrically hospitalized.

Oasis Adolescent Campus

Description

The Oasis Adolescent Campus provides residential treatment services for adolescent males and females ages 13-17 with behavioral health disorders. The program provides individual and group counseling services. In addition to substance abuse education, relapse prevention and life skills training. The residential program incorporates experiential therapy including therapeutic wilderness trips, day trips and ROPES challenge course into the program design. Residents attend school on-site; receive group counseling twice per day, individual counseling at least once per week, and family counseling twice per month (if applicable). Residents are offered a unique opportunity to participate in the Cirque du Monde program working and performing with trainers from Cirque de Soleil. Cirque du Monde provides a unique approach to building team skills and developing personal confidence **Budget**

Veterans Programs

Description

Aspire provides several services that assist veterans. Supportive Services for Veteran Families works in partnership with the VA and several other community agencies in order to provide assistance to veterans and their families who are in crisis and/or at risk of losing their housing. Aspire also offers residential services for veterans through the Operation Center Focus program. The Operation Center Focus Men's Program is located in Orange County and provides transitional housing and supportive services for male veterans who are homeless and in need of substance abuse services. The program includes medical evaluation, mental health counseling, psychosocial support, education/vocational training, and any other additional services to help veterans focus on recovery and the restoration of a healthy, responsible lifestyle. Operation Center Focus also operates a women's program in Brevard County.

For veterans in need of outpatient services, the Steven A. Cohen Military Family Clinic at Aspire Health Partners provides accessible, confidential, high-quality behavioral healthcare services and case management resources to veterans, their families, and the families of Active Duty, National Guard, and Reserves, including spouse or partner, children, parents, siblings, caregivers, and others. Services are available regardless of discharge status, role while in uniform and combat experience. The Steven A. Cohen Military Family Clinic is physically located in Tampa, and all clinic services are available throughout the state of Florida via telehealth options. Cost will never be a barrier to any veteran seeking care through the Cohen Clinic.

Description

The ANCHOR Program is an integral component of the Orange County Central Receiving Center (CRC) service system. ANCHOR provides transitional housing with case management and overlay services to chronically homeless adults who have substance abuse and/or mental health disorders and need support in their recovery. Services include group and individual therapy, case management, employment assistance, AA and NA meetings, recovery support, housing assistance, and medication observation. ANCHOR serves individuals who have been referred through the Central Receiving Center, Detox, Orange County Jail, Outpatient services, and outside providers. ANCHOR is operated by Aspire and is a collaborative effort with Orange County Government. Most individuals stay at ANCHOR for approximately six months. **Budget**

HOME

Description

Helping Others Make the Effort (HOME) is working to break the cycle of homelessness by providing bridge housing and supportive services to homeless single women with children. HOME offers several program options, dependent on the individual family's need and housing urgency. Services include outreach, intake, referrals and case management. When a family first contacts HOME for service, a five to ten minute screening is used to determine if the family gualifies for HOME services or needs a referral to another agency. IF a family can be helped by HOME, an appointment will be set for them to come to the office for a more in-depth assessment of needs. HOME provides assistance with making applications for food stamps and other available benefits, case management and life skills education. Budget

The Florida Assertive Community Treatment (FACT) Team is made up of a 24-hour, multidisciplinary, mobile group of treatment providers including a psychiatrist, psychiatric nurses, counselors, case managers, a vocational specialist, a substance abuse specialist and a peer counselor. Treatment services are individualized and staff assist the individual in meeting their goals. Services are provided in a continuous rather than time-limited framework. The FACT team's goal is to maintain the individual in the community in order to divert them from requiring more intensive services. **Budget**

The Addictions Receiving Facility is a centralized receiving center for adult individuals in need of assessment and medically-supervised detoxification and stabilization with substance abuse or co-occurring disorders. The facility operates 24 hours a day, 7 days a week, and individuals can be voluntarily admitted or involuntarily admitted through the Marchman Act. If assessed to need further treatment, individuals can be referred for continued residential services. Aspire has several short-term residential substance abuse treatment centers for adults, including the Men's Residential Recovery Program in Orlando; The Women and Children's Residential Treatment Program in Orange County which allows pregnant, postpartum, and other women with children to receive residential services; the Women's Residential Program in Seminole County; Women's Residential Brevard; and the Seminole Center for Co-Occurring Disorders (SCCD), a residential program that provides the opportunity for individuals with co-occurring disorders to reduce the frequency and severity of substance abuse while learning healthy coping skills for addressing their mental health diagnosis. Description

The PATH teams in Orange and Seminole County serve the homeless who have a mental health or co-occurring disorder. The team provides case management services to ensure continuity of care through assessment, monitoring, individualized planning and linking to community resources including assistance with finding housing. Case Managers ensure the client has access to all needed and appropriate services. In Seminole County, the HOPE Team (Homeless Outreach Partnership Effort) is an outreach team that serves the homeless living on the streets, in abandoned buildings, and in camps. The team will come alongside homeless individuals to understand their needs and link them to ongoing services that will empower them to obtain and maintain stability in the community. The program is funded through a partnership with the Homeless Services Network of Central Florida. Our PATH program serves the homeless who have mental illness or co-occurring disorders. Aspire also has several residential programs that provide housing and support to individuals with mental illness, such as ANCHOR, Bay House, and College Place Apartments, as well as many substance abuse residential programs.

CEO/Executive Director/Board Comments

In July, 2014, Lakeside Behavioral Healthcare, The Center for Drug-Free Living and Seminole Behavioral Healthcare merged to form the new company, Aspire Health Partners, Inc. One of the most challenging aspects of that merger has been the consolidation of three separate Finance departments and the corresponding revenues and expenditures of the three partners. During Fiscal Year 2015-2016, that consolidation was completed. Two of the most significant indicators of this consolidation is the completion of a 990 Tax Filing and a single independent audit covering the entire new company.
